## **QLD STATE ELECTION 2024**

### Queensland's state election on 26 October comes at a critical time.

The State is navigating a variety of social, economic and environmental challenges in areas such as housing, cost-of-living, climate change and capacity constraints, whilst also being on an exciting journey with opportunities in renewable energy, revitalized industries and Brisbane 2032.

In this context, it's vital there is clear policy direction for several key industry sectors, as well as a need for our political leaders to engage and build trust with Queenslanders.

Unlike many other parts of the world, Australia has strong political and civic institutions which support good policy and law-making and can respond effectively to change. However, as everyone knows, governments need input from industry, representative groups and the public to help it improve.

This input is especially needed around elections when political parties develop their policies, and when newly elected Governments implement their agenda.

## Regional skills issues

INTERACT is finalising its support to Manufacturing Skills Queensland (MSQ) in the Manufacturing Future Workforce Transition Project, an initiative funded by the QLD Government's VET Emerging Industries initiative.

Since October 2023, a cross section of 34 manufacturers have been interviewed on changing skill and workforce needs, and strategies to adapt to changing social and economic conditions. A final report of the will be shortly submitted to MSQ for their consideration.

## **Jobs Queensland**

INTERACT has finalized its work with Jobs Queensland (JQ) on workforce attraction and retention for the State's health and community services sectors.

It is projected that these sectors will employ more than 440,000 people in the State by 2024-25.

INTERACT undertook desktop research and interviews with sector and government leaders (including Queensland Care Consortium members) to identify policy improvements to support workforce strategies for the sector.
